 - **Exhibit A** – The unclassified Certification of the Application for the Removal of Nazira Haji Zada;

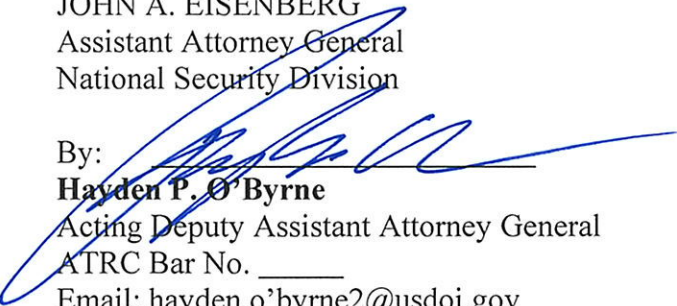
